

5. LANDOWNERS' MAP AND LIST

In accordance with 30 TAC §330.59(c)(3)(B) and §305.45(a)(6)(D), the landowners' list presents the names and mailing addresses of the landowners of property within one-quarter (1/4) mile of the facility, as provided in Table 5-1 below. The numbering in the landowners' list corresponds to the numbers on Drawing C0.03, which depicts the locations of the landowners' tracts. The landowners' list and map are based on the San Jacinto County Appraisal Districts' property records, which do not identify any mineral interest ownership under the facility.
